4. Prior to booking an AAT exam, the student's personal tutor must agree in writing that the student is ready to sit their exam.
5. We will cover the cost of exam re-sits where the exam center charges an invigilation fee of £45 or less.

ADDITIONAL TEXT BOOKS: At Foundation Level, all of our learning materials are on-line, comprising of interactive presentations, with voice-overs (and transcripts) and practical accounting activities to print off and complete, including progress tests to submit for marking and feedback. We don't therefore use traditional study manuals at Foundation Level. However, they are available as an optional extra, costing £120 (inc. postage) for the full set.
